WHEREAS, the Fort Atkinson Youth Wrestling Club is a Nonprofit Organization within the meaning of the laws of Wisconsin: and WHEREAS, the Fort Atkinson Youth Wrestling Club provides an opportunity for children Kindergarten through eighth grade An opportunity to learn the basic fundamentals of wrestling in a structured environment; and WHEREAS, the Fort Atkinson Youth Wrestling Club and its participants understand and recognize that there is a possibility for Injury while engaging in the sport of wrestling; and WHEREAS, the Fort Atkinson Youth Wrestling Club and its participants specifically wish to limit the liability of the Fort Atkinson Youth Wrestling Club and School District of Fort Atkinson, WI. IT IS HEREBY AGREED BY THE UNDERSIGNED PARTICIPANT AS FOLLOWS: I/We agree to indemnify and hold harmless the Fort Atkinson Youth Wrestling Club, including all officers, agents, and employees along with the School District of Fort Atkinson from any and all losses, claims, lawsuits, and/or actions for damages stemming from and incident occurring while participating with the Fort Atkinson Youth Wrestling Club. The term "incident" shall be defined broadly to include any damage to person and or property while participating with the Fort Atkinson Youth Wrestling Club. The term "participation" shall also be defined broadly to exclude liability for damages resulting from practices at Fort Atkinson High School in Fort Atkinson, Wisconsin, practices at other locations, tournaments held by the Fort Atkinson Youth Wrestling Club wherever so situated. Participation at meets or tournaments as a member of the Fort Atkinson Youth Wrestling Club, wherever they might be held and any and all travel to and from this above stated participation. I/We agree to abide by all requirements, regulations and procedures, whether communicated in writing or given orally during participation as to the Fort Atkinson Youth Wrestling Club, so as to insure the protection of all participants, equipment, employees and the assets of the Fort Atkinson Youth Wrestling Club, and School District of Fort Atkinson, WI.
